



## The Coalition to Save our Military Shopping Benefits

Dear Senator Inhofe:

As the Coalition representing the millions of military patrons and beneficiaries of exchange and commissary programs, we urge you to reject the Kennedy Amendment #718, which calls for a report on the management of military commissaries and exchanges and a two billion dollar reduction.

We strongly believe this amendment is unnecessary and disruptive as the Department of Defense (DoD) is still implementing language included in the Fiscal Year 2016 National Defense Authorization Act (NDAA) to transform the management of commissaries. DoD and the Government Accountability Office (GAO) have already reported to Congress on the state of these transformation initiatives. DoD needs time to absorb the legislative authorities and implement any sensible changes to these benefits before another wave of reductions and changes are proposed.

Thirty-nine military and veterans organizations supported important legislation introduced in the House, which would put in place needed protections to safeguard these valuable earned benefits for service members and their families. The Military Patron Protection Act (MPPA) of 2017 (H.R. 2850), advanced by Representatives Walter Jones and Tim Walz is designed to give patrons a voice in the management of these programs. We strongly suggest including similar language in the Senate Bill as an alternative to the Kennedy Amendment.

Military patrons have invested billions of dollars from their own pockets for financing exchange and commissary construction programs, along with hundreds of millions of dollars annually to support on-base morale, welfare, and recreation programs. The MPPA would provide patrons with transparency and a much needed voice in the sourcing and application of this funding, how these benefits are structured going forward that effect their investments, and how patron financial contributions to these programs are being allocated. This legislation would also provide needed visibility for impacts on associated small and disadvantaged businesses, and a wide range of benevolent causes that are enabled through patronage of these programs.

On behalf of the millions of service members, Guard and reserve, veterans, survivors, and military family members who rely on these critical benefits, we respectfully urge rejection of the Kennedy Amendment #718 and your consideration of this legislation during your deliberations of the Fiscal Year 2018 National Defense Authorization Act.
